MEMORANDUM OF UNDERSTANDING

AND WHEREAS the Party of the Second Part has the financial means and the desire to support 300 aspiring students from Nagaland to join the institute for vocational training for employment purposes.

AND WHEREAS the Party of the First Part presented their proposal for vocational training of youths on Hair and Beauty Care and Spa Therapy with placement before the Task Force for 'Capacity Building', Government of Nagaland on 19th November,2008 at the Secretariat, Kohima. On approval of the proposal both the parties now, have agreed to enter in writing the areas of consensus, under a Memorandum of Understanding for the conduct of business.

NOW, THEREFORE, this Agreement witnesseth as under:

I. AIMS AND OBJECTIVES OF THE PROJECT

- To provide quality vocational training in Beauty, Hair and Spa Therapy to 300 unemployed youth of the State to equip them to compete in the national and international job market
- 2. To open job opportunities for the school and college drop-outs
- 3. To provide internationally accredited certificate and make the trained youth suitable for employment.
- 4. To provide job placements to the successful students in India and abroad
- 5. To generate funds for Govt. Of Nagaland to mobilize future projects

The Management of the day-to-day affairs of the institute shall be as per the Memorandum and articles of Association of the Lambency Chrysalis Academy and its bye-law 0 A 228366

III.ACADEMIC PROGRAMMES - COURSES OF STUDY

- The classes for the above said courses shall be conducted by the First Party at C-44, Institutional Area, Noida, U.P.-201301 on regular basis for 5 to 6 hours in a day, five days in a week for a duration of six months only.
- Dates and schedule of examinations for the courses shall be announced by the First Party. The
 centers of examination and valuation of answer scripts and centers for practicals shall be C-44, Sector
 -62, Institutional Area, Noida-U.P.-201031.
- 3. The First Party shall declare results of the students on completion of the course and issue the requisite certificates to the candidates under intimation to the Second Party.

IV. ADMISSION PROCEDURES

A pre-admission interview shall be conducted by the Academic Team consisting of representatives of
the First Party and second party to evaluate suitability of the candidates after the print advertisement
in the local papers inviting applications from interested candidates for the course. For the purpose of
conducting interview the Second Party shall facilitate location of infrastructure and logistics.

2. Filled-in applications from the prospective candidates will be received by First Party. On completion of the selection as per eligibility norms, the list of eligible candidates shall be forwarded by the First Party to Second Party for approval.

V. PROJECT COST

The fee is inclusive of charges for training programs, personal tool kit, products and equipments needed in theoretical and practical instruction, accommodation and fooding.

The Actual Project fees for 300 students is t total of Rs.3.30 Crores however 75% of the fees will be borne by Govt. Of Nagaland amounting to Rs.2.48 Crores and balance of 25% of the fees will be borne by students amounting to Rs.82.50 Lacks.

VIII. PROCEDURE FOR PAYMENT

- 1. The fee shall be released by the Second Party to the First Party in the form of cheques drawn in favor of "Surya Vinayak Wellness Ltd.".
- 2. The Second Party shall pay to the First Party the course/boarding/lodging fees for the number of students selected and admitted for the course in each batch.
- 3. The Second Party shall pay to the First Party the applicable fee in three installments;40% on commencement of the course, 30% two months after the commencement of course and the balance 30% on receipt of the job placement list.

IX. ROLES & RESPONSIBILITIES OF FIRST PARTY.

- 2. The First Party shall receive applications against the advertisement for admission to the said course.
- 3. The First Party shall screen & shortlist candidates along with officials of Government of Nagaland
- 4. The First Party shall commence the course on receipt of 40% of the course fee.
- The First Party shall provide the entire infrastructure facilities including classrooms, laboratories, equipments, analytical tools and aids, library and qualifies staff. Facilities for boarding and lodging of students, counseling and guidance on courses will also be provided.
- 6. The track records of Attendance and the Internal Evaluation shall be done by the First Party and shall be submitted to the Second Party periodically.
- 7. The First Party guarantees employment and placement with a minimum salary of Rs. 8000/-(Rupees eight thousand) only PM to all successful candidates after the completion of certification from HABIA.
- 8. The First Party shall furnish the placement record with work place addresses and details of remuneration to the Second Party.
- The First Party shall not tolerate any kind of indiscipline which could be under the influence of drugs/alcohol, insulting fellow class mates either verbally or physically, damaging the property, theft, racism, ragging, hatred or sexual harassment. The First

Party shall have the right to dismiss offenders from the academy immediately and the tuition fee shall not be refunded or adjusted under any circumstances. In such cases replacement shall be made by the Second Party with deserving candidates at no extra cost.

10. In case the First Party fails to fulfill any of its obligations towards providing training and certification to the successful students and job placement on successful completion of the course, the First Party shall be liable to pay back corresponding amount paid by Government of Nagaland and to the students within a period of six months from the date of such a default. In case the First Party fails to do so, recovery of the Governments money and those of the students will done from the First Party as per law. This clause is not applicable to the students who do not want placement or leave the course for which a signed declaration by the candidate shall be furnished.

X. ROLE & RESPONSIBILITIES OF THE SECOND PARTY.

- The Second Party shall be responsible for all administrative work relating to collection of fees from the students.
- Of the total course fee the Party of the Second Part shall pay to the Party of the First Part 75% of the fees, the remaining 25% shall be collected by the Second Party from the students and paid to the First Party.

- 3. Any expansion or modification relating to the academic programmes shall be decided jointly by both the parties.
- 4. Both the parties shall be responsible for monitoring the progress of the students.
- 5. Both parties shall ensure that all students who have successfully completed the course find placement six months after completion of the training course at Lambency Chrysalis Academy

XII. TERMINATION

THE parties Neveto shall have the right to terminate this Agreement by Aving 2 months notice to the other party in any of the following cases:

1. If the terms and conditions of this Agreement are not complied with

Or

2. If parties hereto mutually decides to terminate the Agreement.

XIII. ARBITRATION

If any dispute and/or difference whatsoever between the parties arises relating to the financial assistance or effect of this Agreement or the validity or the breach thereof the same shall be settled by two arbitrators appointed from each party. To such arbitration the provisions of the Arbitrations and Conciliation Act, 1996 as amended from time to time shall apply.

The venue of the arbitration shall be at Kohima unless agreed between the parties.

However in the eventuality of any legal proceedings, failing arbitrations arising out of or under this Agreement, shall be subject to the jurisdiction of the Guwahati High Court, Kohima, provide any legal proceeding with respect to violation of the confidentiality provisions or otherwise involving the proprietary rights of either party may be brought in any other courts having complete jurisdiction within or outside of India.

 Departments of Govt. of Nagaland and the provisions of the Rules and Regulations of the State
 Government.
- 5. This MOU shall be valid for a period of one year from this date and can be renewed on mutual consent.
- Any change in the location of the registered office of the Centre shall be done only with the prior mutual concurrence of the parties.
